

UCAS Tariff point allocation for T Levels

This short guide aims to provide Higher Education Providers with all the information required to understand the allocation of Tariff points to fully-achieved- and partially achieved T Levels.

The exam levels for the different parts of the T Level are:

TL Overall Grade

TM Core Component

TN Specialism

42 Industry Placement

Fully achieved T Level

Learners who achieve their full T Level are eligible to receive the following points, based on the **Overall T Level grade**:

Overall T Level Grade	Points
D*	168
D	144
М	120
P (A*-C)	96
P (D-E)	72

How do I know which T Level students are eligible for these points?

The "Overall grade" you receive from UCAS through ABL will contain one of the following values:

- D*
- D
- M
- P

If the overall grade is "P", how do I know if the learner has 72 or 96 points?

You will need to check the grade for the Core Component, which will be shared with you through ABL:

Overall grade P + Core grade A*/A/B/C = 96 points

Overall grade P + Core grade D/E = 72 points

Partially achieved T Levels

Tariff points for partially achieved T Levels are based on the weighting of the component parts of the technical qualification.

There are currently two different proportional splits:

- 1) Core component and Occupational Specialism are worth 50% each.
- 2) The Core component makes up 40% of the weighting and the Occupational Specialism makes up 60%.

Partially achieved T Level Tariff points are awarded in the following scenarios:

- 1) Learner has achieved their Core component AND Industry Placement (IP)
- 2) Learner has achieved their Occupational Specialism AND Industry Placement

How do I know if a learner is eligible for these points?

The "Overall grade" you receive from UCAS through ABL will have the following value:

PA (which stands for Partially Achieved)

How do I know if the learner has achieved their Industry Placement?

UCAS will send you a "grade" for the Industry Placement through ABL:

- "P" indicates the Industry Placement has been completed.
- "PC" (Partially completed) or "NC" (Not completed) indicates the IP has not been achieved.

A learner has completed their Core component and Occupational specialism but not their Industry Placement – do they receive Tariff points?

In this scenario the learner does not receive Tariff points.

Partially achieved Tariff points are only awarded in the following scenarios:

- 1) Learner has achieved their Core component AND Industry Placement
- 2) Learner has achieved their Occupational Specialism AND Industry Placement

How to locate the correct points for Partially Achieved T Levels

You do not need to know the weighting of a T Level to work out the correct points because UCAS has listed all T Levels separately in the Tariff Tables. This means you just need to search for the T Level by subject, or by its QAN, to locate the correct points.

- 2) When the spreadsheet has opened, use the right arrow to locate the "T Level Partial Achievement" tab:




3) You can search for the T Level by subject or QAN. The weighting is also provided for your information.
