Top 5 tips on how to support students after the January deadline

- 1. If your students have used all five choices on their applications but are not holding any offers, they may be eligible to use EXTRA when it opens on 28 February. <u>Find out more.</u>
- 2. Students can make some changes to their application after submission, or they might need to contact the university or college. What they need to know.
- 3. Once the application has been submitted, students can sign in anytime to track their application and find out about the <u>different offers</u> they may receive and the dates to reply.
- 4. <u>It's not too late to apply.</u> Applications can be submitted until 30 June 2023 when they will be entered into <u>Clearing.</u>
- 5. Students can access the latest advice on finance and accommodation on <u>ucas.com</u>
